- The students were made aware of registration of documents, Bombay stamp act 1958 etc.

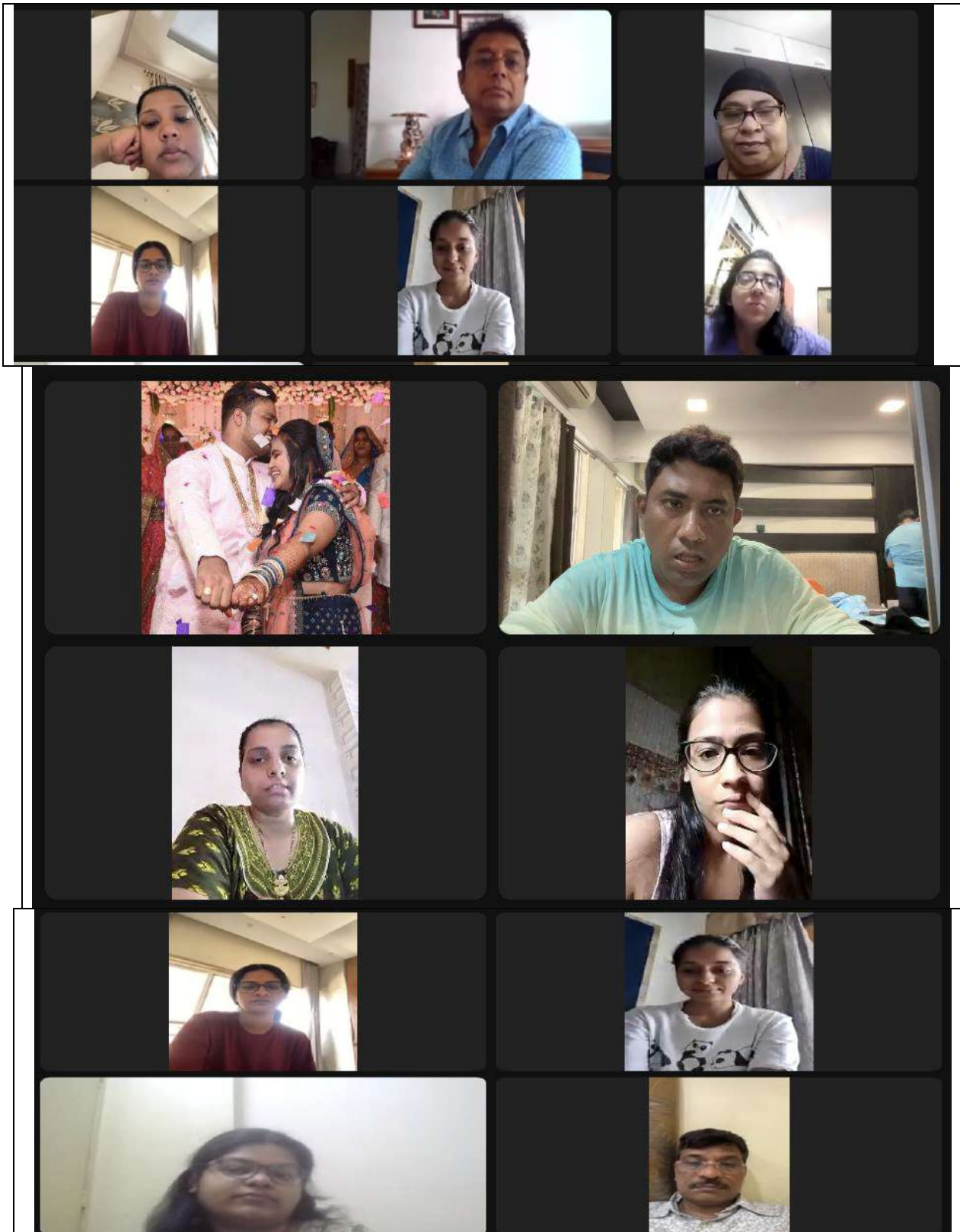

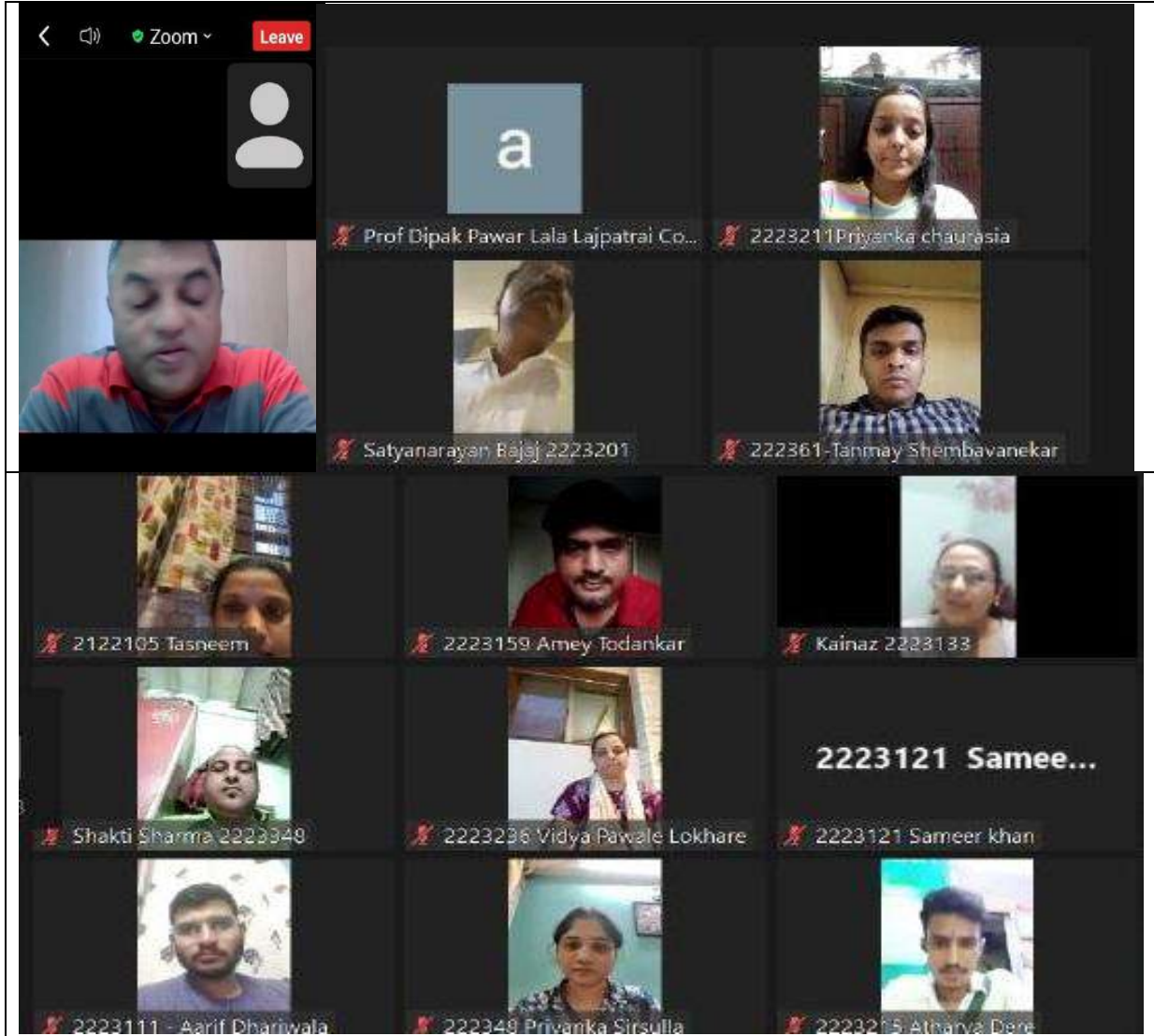
