

- 5) Lok Adalat

All the above proceedings are commonly used in civil proceedings and the role of the Officer is to resolve all types of matter except matrimonial and criminal matters.

- The subjects also came to know that the courts are overburdened with the matters and the only alternate mode is ADR/ODR. The students were over whelmed and overall had a great knowledge about the subject.





Program outcomes:




